### Membership (on sale late June)

*Includes tickets to all High Holy Day services*

Adults: \$400 per person (31 years and older)

Young Adults (ages 13 to 30): \$50

Limited Income (please see guidelines and criteria on the next page): \$120 per person

Children under 13 years of age: Free (registration required)

### Single-Service Tickets

*You do not have to be a member to purchase single-service tickets.  
However, they do not go on sale until mid August (subject to availability).*

Rosh Hashanah Day 1: \$ 175 per adult (31 years of age and older)

Rosh Hashanah Day 2: \$ 175 per adult (31 years of age and older)

Kol Nidrei: \$ 175 per adult (31 years of age and older)

Yom Kippur Morning: \$ 175 per adult (31 years of age and older)

Limited Income Single-Service Tickets (please see guidelines and criteria on the next page): \$60 per person

Children under 13 years of age: Free (registration required)

### Special Members' Benefit

Do you have family and/or friends who wish to join you at Shir Libeynu for just Rosh Hashanah OR Yom Kippur? **Members only** may purchase tickets from late June on for friends and family at a rate of **\$250 each** for Rosh Hashanah (Day 1 and Day 2) OR Yom Kippur (Kol Nidrei and Yom Kippur morning). **All members may purchase the special members' benefits tickets, including those who qualify and purchase a limited income membership (see limited income guidelines and criteria on the next page).**

Adults: \$40 per person

Children under 13: \$10 per child

## LIMITED INCOME CRITERIA AND GUIDELINES

Congregation Shir Libeynu endeavours to ensure that no one is turned away from our services because of a lack of resources to pay for tickets and/or memberships. Shir Libeynu tries to maintain a fair and consistent pricing policy that balances accessibility with accountability and that also adequately funds our congregation throughout the year.

Our High Holy Days order form (available late June 2015) includes specific criteria to help congregants buying memberships or individual tickets determine whether they fit into the Limited Income category.

If you fit any one of the criteria below, you are automatically entitled to a Limited Income (LI) membership or, subject to availability in mid-August, LI single-service tickets.

### **Limited Income Criteria**

#### Individuals

*You may purchase one LI membership or single-service LI tickets for one person (on sale mid-August, subject to availability), if you fit into one of the following criteria:*

- \* An individual making less than \$35,000 in gross annual income
- \* A senior citizen living exclusively on a fixed government income (i.e. OAS, GIS, or CPP)
- \* A person living exclusively on a fixed income (i.e. social assistance, employment insurance, government disability assistance)
- \* A full-time student over 30 years of age (those 30 years of age or younger are entitled to our \$50 membership)

Households (A household consists of two adults over the age of 30 sharing a home)

*You may purchase a combination of two of the following: LI memberships or single-service LI tickets (on sale mid-August, subject to availability), for two people if you fit into one of the following criteria:*

- \*A household making less than \$50,000 in gross annual income
- \*Senior citizens living exclusively on a fixed government income (i.e. OAS, GIS, or CPP)
- \* A household living exclusively on a fixed income (i.e. social assistance, employment insurance, government disability assistance)

**If you fit into one of the above criteria, you will be able to indicate your eligibility on our High Holy Days order form. Confirming your eligibility will allow you to purchase your limited income memberships or tickets when all memberships (late June) and single service tickets (mid August, subject to availability) go on sale.**

If you do not fit into the above categories and believe you require Limited Income consideration, requests may be made by emailing [shirlibeynu@yahoo.ca](mailto:shirlibeynu@yahoo.ca) and we will contact you once our membership sales begin in late June.

Please note that due to the determination process, Limited Income applications that do not fit into one of the automatic criteria cannot be granted at the door. Requests for special consideration *must be made in advance* and must include all requested information. **ALL INFORMATION PROVIDED IS CONFIDENTIAL.**
