

2018 HIGH HOLY DAYS PARKING INFORMATION

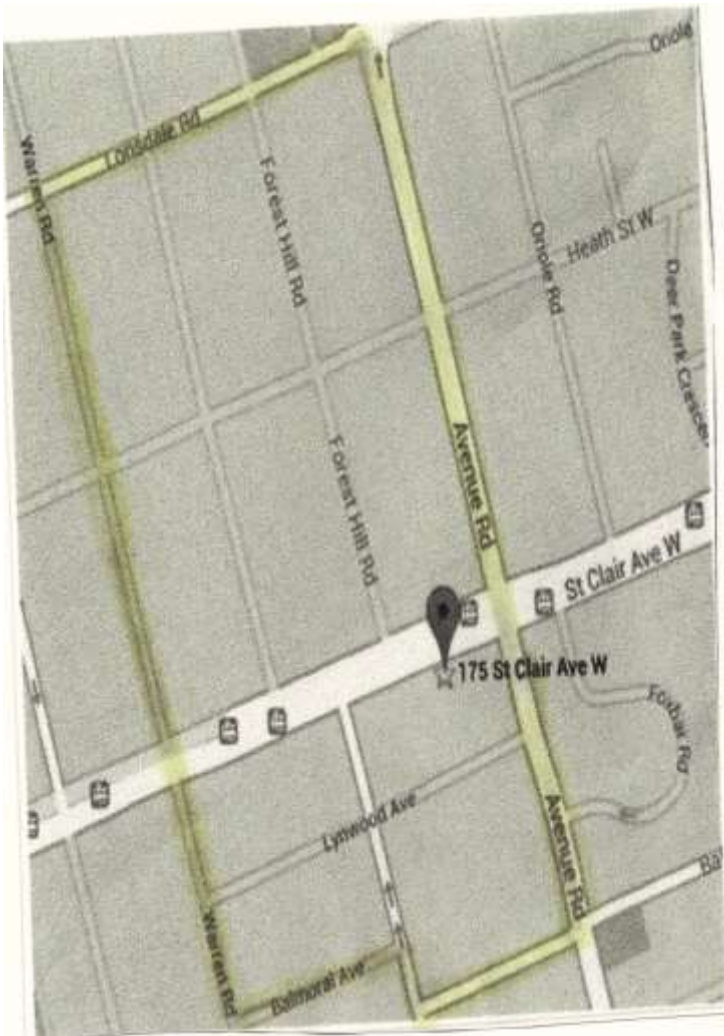
The Toronto Police Service Parking Enforcement Office will advise officers to allow parking leniency whenever possible at the locations and times listed below.

However, we encourage congregants to use any available paid parking in the area, as there is no guarantee that enforcement will not take place.

Officers will be instructed to give parking leniency to Shir Libeynu congregants attending our High Holy Day services at First Unitarian Congregation, 175 St. Clair Avenue West on the following dates and times:

- Rosh Hashanah Eve — Sunday, September 9, 5:00 p.m. – 12:15 a.m.
- Rosh Hashanah Day 1 — Monday, September 10, 8:30 a.m. - 2:30 p.m.
- Rosh Hashanah Day 2 — Tuesday, September 11, 9:00 a.m. - 2:30 p.m.
- Kol Nidrei (Yom Kippur Eve) — Tuesday, September 18, 5:00 p.m. – 11:15 p.m.
- Yom Kippur — Wednesday, September 19, 9:00 a.m. – 10:15 p.m.

Parking leniency applies to the area highlighted on the map below



This leniency **only** applies to:

Temporal parking regulations (i.e. 1-hour and 3-hour maximum time limits) and "No Parking" areas

Leniency does not apply to following:

North side of Lonsdale Road. The north side of Lonsdale road is a school zone and therefore anyone who parks on the north side will be ticketed and towed. You may only park on the south side of the street on Lonsdale Road.

St. Clair Avenue West, where parking is not permitted during all signed rush hour restrictions.

Avenue Road – there is no parking permitted on this road **at any time.**

Pay Parking locations

On streets during times when **Permit Parking is in operation**

Enforcement will still take place of all other parking, stopping, and standing prohibitions, as well as No Parking within 0.6 m of a driveway or within 15 m of an intersection and pay-and-display parking.

It is suggested that you print this letter and put it on your dashboard as a reminder to the Toronto Police Service of the special parking leniency.

Shir Libeynu is not responsible for any tickets issued by the parking authorities. Please see the other side of this letter for instructions on how to proceed if you receive a ticket.

On August 28th 2017 the City launched a new process for parking ticket disputes. The new Administrative Penalty System "APS" administers **all parking ticket penalties and disputes**. Should you receive a ticket, please exercise one of the available options on the back of the ticket. More information: toronto.ca/aps

The following is City of Toronto Parking Ticket Cancellation Guideline for Religious Observances.

For religious observances, parking tickets may be cancelled for the following infractions:

- Park at expired meter
- Park during prohibited times (excluding rush hour)
- Park signed highway in excess of permitted time

Evidence must be provided to establish that the criteria for cancellation have been met, including:

1. A letter or correspondence from the Minister or head of a religious group that identifies the time, date and location of the religious observance or service. (Letter below)

Congregation Shir Libeynu will be holding our 2018 High Holy Days services from September 9-11 and September 18-19.

As we do not have a permanent building, our services will take place at **First Unitarian Congregation of Toronto, 175 St. Clair Avenue West, Toronto**. As there is no parking for our congregants at the First Unitarian site, we have asked the parking office for enforcement leniency to our congregants who are parking in the surrounding area. You may find the areas we requested leniency on the other side of this letter.

Our congregants will need to park in the area on the following dates and times:

- Rosh Hashanah Eve — Sunday, September 9, 5:00 p.m. – 12:15 a.m.
- Rosh Hashanah Day 1 — Monday, September 10, 8:30 a.m. - 2:30 p.m.
- Rosh Hashanah Day 2 — Tuesday, September 11, 9:00 a.m. - 2:30 p.m.
- Kol Nidrei (Yom Kippur Eve) — Tuesday, September 18, 5:00 p.m. – 11:15 p.m.
- Yom Kippur — Wednesday, September 19, 9:00 a.m. – 10:15 p.m.
